**THE VILLAGE BOARD OF THE VILLAGE OF BONDUEL, SHAWANO COUNTY, WISCONSIN, DO ORDAIN that the Municipal Code of Bonduel, Wisconsin, Chapter 107 Planning, Section 107-1 Adoption and Review of Comprehensive Plan is hereby amended as follows:**

**Sec. 107-1. – Adoption and review of comprehensive plan.**

- (a) Wis. Stats. § 62.23(2) and (3) authorizes the Village to prepare and adopt a comprehensive plan as defined in Wis. Stats. §§ 66.1001(1)(a) and 66.1001(2).
- (b) The Plan Commission undertook relevant studies and surveys, including data collection and analysis.
- (c) The Village Board adopted a public participation plan to encourage public participation in the formation and review of the comprehensive plan.
- (d) The Plan Commission held numerous public meetings to involve citizens in the preparation and review of the comprehensive plan.
- (e) The Plan Commission has completed a comprehensive plan consisting of text and maps that is entitled "Village of Bonduel Comprehensive Plan: 2018-2038."
- (f) The Plan Commission by a majority vote of the entire commission recorded in its official minutes, has adopted a resolution recommending to the Village Board the adoption of the above-mentioned comprehensive plan, containing all of the elements specified in Wis. Stats. § 66.1001(2).
- (g) The Village Board, in compliance with the requirements of Wis. Stats. § 66.1001(4)(d), held a public hearing, with proper public notice, on December 5, 2018, to receive public comment on the above-mentioned comprehensive plan.
- (h) The Village Board has reviewed the above-mentioned comprehensive plan, considered the public input it has received, and revised the above-mentioned comprehensive plan.
- (i) The Village Board has determined that the above-mentioned comprehensive plan, as revised, is in the public interest and that it is needed for guiding and accomplishing the coordinated, adjusted and harmonious development of the Village and its extraterritorial area which will, in accordance with existing and future needs, best promote public health, safety, morals, order, convenience, prosperity or the general welfare, as well as efficiency and economy in the process of development.

(j) The Village Board, by majority vote of the entire board, adopts the comprehensive plan, as revised, entitled "Village of Bonduel Comprehensive Plan: 2018-2038."

This ordinance shall take effect upon passage and publication and/or posting as provided by law.
